Seasonal Memberships

8-Month Winter Tennis Membership

September 1 thru April 30 - **Tennis only**

4-Month Summer Membership

May 1 thru Labor Day - **Tennis & Pool**

4-Month Pool Membership

May 15 thru September 15 - **Pool only**

Pay in full **one month prior** for any full seasonal membership and get a **5% discount!**

Seasonal Reserved Court Time

If you like to avoid calling for court reservations, our reserved seasonal court time is for you.

- Each group reserving court time shall appoint a captain to remit entire court fee together with names/membership fees for all group members.
- Previous-year court assignments will be held till April 15th, pending receipt of deposit. After this date, reservations are accepted in order of request.
- All make-up time will be scheduled at the discretion of FSRC management.
- Courts may be re-assigned at the discretion of Four Seasons management.

Club Regulations

- All players are required to check in at the front desk before proceeding to the courts.
- Upon completion of assigned time, players are required to leave the court.
- Provided the club is given 24-hour advance notice, a member may cancel a court reservation without charge. For later cancellations, the member will be charged, if court time remains unsold and no other courts are available.
- Children under the age of 12 must be supervised in all areas of the club, unless they are participating in one of our programs.
- Use of all facilities is at player's own risk.
- We cannot assume responsibility for personal property on club premises.
